#### **About Us**

The Moakley Center has been working with local and regional public agencies and nonprofit organizations for over **47 years** providing education, training, and research opportunities for public servants and community leaders.

Our history goes back to 1973 when the New England Commission provided funding to Suffolk University to develop programs to help the public service workforce do their work more efficiently and effectively. Initially, the focus was academic, resulting in the roll out of the undergraduate Public Administration major and the Master's in Public Administration degree in 1975.

In the 1990's, the Center of Public Management, later named after the late Congressman Joe Moakley, recognized the need to go beyond the classroom. The center developed into a self-sustaining organization within the Sawyer Business School, reflecting the goals of Congressman Moakley. Today, the Moakley Center's mission is to bridge the resources of academia with the needs of the community. Its priorities are to:

Promote dialogue on important public policy issues



Support and advise community organizations in meeting their service missions

#### 2020-2021 Highlights from the Moakley Center:

In the 2020-21 Academic Year, there are **147** students enrolled in **8** certificate programs with **6** different partners.

- Undertook 15 public discourse, training, evaluation, and technical assistance projects, in partnership with 12 community organizations, earning revenues of over \$500,000.
- Held **2** seminars in local government financial management in partnership with the Massachusetts Municipal Association.
- Offered certificates in the following areas:
  - o Certificate in Public Service Leadership and Management
  - o Certificate in Community Health and Community Health Center Management
  - o Certificate in Nonprofit Human Services Management
  - o Certificate in Local Government Leadership and Management
  - Certificate in Health and Disability Policy
- Collaborated with the Department of Children and Families to offer, for the second time, a Certificate in Human Services Management.
- Developed a new certificate for Faith-Based Non-Profits, which begins in January of 2022.
- Successfully graduated 206 students from Certificate Programs and 58 from seminars, with a cumulative of 2,539 graduates.

#### UMass Medical School/Shriver Center LEND Program

For twenty-one years, the Moakley Center has partnered with the Shriver Center's Leadership Education in Neurodevelopmental and Related Disabilities (LEND) program to offer a *Certificate in Disability and Health Policy* and a joint *LEND/MPA Program*. The LEND Program is dedicated to understanding and improving the challenges faced by individuals with intellectual and developmental disabilities (IDD) and their families. The LEND program is a Human Resources and Services Administration (HRSA) initiative. There are 40 LEND programs across the country, but Shriver's LEND program stands out because of its unique relationship with the Moakley Center. LEND fellows participating in the certificate program can elect to apply their \$12,000 fellowship award from HRSA towards an MPA at Suffolk University. In addition, Suffolk generously gives a one semester fulltime scholarship to LEND fellows and allows for up to 12 graduate credit waivers (for classes completed in the certificate program). As a result, LEND fellows taking MPA courses during their LEND experience have only 3 remaining courses to complete upon graduation from the certificate program. Carol Curtin and Sandy Matava are the Shriver Center's liaisons for the LEND program.

#### Executive Office of Health and Human Services/EOHHS -

This year marked the sixth year of partnership with the Executive Office of Health and Human Services (EOHHS) and the *Certificate in Human Service Leadership and Management*. A total of 20 students graduated in June 2021, coming from departments across the agency including Dept. of Children and Families (DCF), Dept. of Transitional Assistance (DTA), Dept. of Mental Health (DMH), Dept. of Public Health, Dept. of Youth Services (DYS), MassHealth, Dept. of Education (DOE), and the Executive Office of Health and Human Services. Imad Sandakly, Director of EOHHS Center for Staff Development is the liaison for the program and the Center.





Dan Tsai, the former Assistant Secretary for MassHealth and Medicaid Director of the Commonwealth, was the 2021 Keynote Speaker at Graduation. Tsai is the current Director of Center for Medicaid and CHIP Services in the Biden Administration.



#### The Massachusetts Council of Human Service Providers —

After nineteen years, the Providers' Council has celebrated over 500 graduates receiving a *Certificate in Nonprofit Human Services Management*. The Providers' Council is the state's largest human service trade association and is widely recognized as the official voice of the private provider industry. The thirty-eight (38) students in the 2021 graduating class represented 18 different nonprofit organizations including Action for Boston Community Development, Advocates Inc./Guild, Bay Cove Human Services, Brockton Area Multi-Services Inc., Casa Myrna, Centerboard, Central Boston Elder Services, Heading Home Inc., Lifeworks, Mental Health Association, Metropolitan Housing Boston, Northeast Arc, North American Family Institute (NFI) Massachusetts, Pine Street Inn, Roman Music Therapy Services, Roxbury Youthworks, WCI (Work, Community, Independence), and Western Massachusetts Training Consortium. Mia Alvarado, Executive Director, Roxbury Youthworks, Inc. was the 2021 Graduation speaker.



#### Massachusetts Municipal Association (MMA) —

For the ninth consecutive year, the Massachusetts Municipal Association (MMA) offered a *Certificate in Local Government Leadership and Management*. In 2021, the program was offered on Zoom. There were 37 participating communities: Amherst, Arlington, Bellingham, Burlington, Barnstable, Buzzards Bay, Chatham, Cohasset, Danvers, Dartmouth, Dedham, Essex, Foxborough, Franklin, Gardner, Gloucester, Harvard, Hopkinton, Marlborough, Mashpee, Mattapoisett, Medfield, Melrose, Millis, Milton, Newton, Norwell, Norwood, Pepperell, Provincetown, Sandwich, Sudbury, Tisbury, Truro, Westborough, Wrentham, and Yarmouth. The Moakley Center's liaisons with the MMA are Senior Fellow John Petrin (Retired Town Manager of Burlington) and MMA Liaison Katie McCue (Director of Administration & Finance).

#### MMA/MCPM Offers Seminar in Municipal Financial Management ————

In March of 2019, MMA launched a new seminar for local government managers in financial management. The 5-week program has become an annual tradition among the Moakley Center's offerings. Topics include Municipal Finance Law, Capital Budgeting, Local Option Taxes, Internal Controls, Tax Recapitulation, Property Assessment, Personnel Management and Financial Forecasting. The seminar was offered in the Fall of 2019 in New Bedford and in Newton in the Spring of 2020. In Fall 2021, the seminar was held online over Zoom in 9 modules over a five-week period. In Spring of 2022, we plan to host an additional online seminar.

#### **Alumni Spotlight**

Moakley Center student, John Porter, is now Deputy Chief of Police in Hopkinton, MA. John has worked in public service since age 19. He is taking the Moakley Center courses to prepare for budget season so he can better assist Chief Joseph Bennett. Chief Bennett states, "Throughout his career, Deputy Porter has demonstrated commitment to the organization and the community. As we look toward the future, I am excited to work with him as we move the organization forward."



#### Massachusetts League of Community Health Centers (MLCHC) -



In its 20th year of offering the *Certificate in Community Health & Community Health Center Management*, the Mass League celebrated its 476th graduate. Program sponsors included: Boston Health Care for the Homeless, Community Health Connections, East Boston Neighborhood Health Center, Edward M. Kennedy Health Center, Greater Lawrence Family Health Center, Harbor Health Services, HealthFirst Family Care Center, Holyoke Health Center, Lowell Community Health Center, Lynn Community Health Center, South Boston Community Health Center, Southern Jamaica Plain Health Center, and Upham's Corner Health Committee.

#### Moakley Entrepreneurial Practice Program (MEPP) —

The Moakley Entrepreneurial Practice Program is a three (3)-credit PAD graduate course, designed and implemented by the Moakley Center to provide students who have professional experience with the opportunity to design, implement, and evaluate a project that is intended to improve the impact and/or effectiveness of a public service issue. The MEPP provides up to \$2,000 for a student to use in carrying out the project. The program can last up to 12 months and provides each student with a Project Coach who will be available for at least 30 hours over the duration of the program. It is expected that a MEPP student will spend a minimum of 100 hours carrying out the project and will make a formal presentation to invited guests (including IPS faculty) upon completion. 2020-21 projects included:

#### The 360 Degree Institute

As part of MAPP, Val Joseph chose to develop, implement and evaluate the 360 Degree Institute. The purpose of the Institute is to provided international students, especially those from homogeneous societies and overly goal-driven education systems (such as China), with workshops and educational contents on topics such as identity, race and diversity. Five workshops were held with 55 participants. In addition she started an Instagram account (@360degreehumanins) for international students in the U.S., featuring international student experience, tips, identity, sexuality, and identity. The social media account serves as a tool for international students to learn knowledge important to their lives in the U.S. (such as F1employment process) and be exposed to concepts such as diversity.

#### R Yola (Remember-You Only Live Once)

Donna Lee took the MEPP program to a new level by winning an award for her project at the 2021 Suffolk IP Pitch Competition. The idea was born out of a desire to live a healthier life style by practicing yoga. Concerned about the cleanliness of yoga mats (particularly in light of the pandemic) and filling up landfills with old yoga mats, led her to design a mat that is quick-drying Turkish towel, a layer of foam and a non-slip bottom. The competition is an initiative. This project was a pilot venture between the Institute for Public Service, the Moakley Center, and of Suffolk's Entrepreneurial Program.



#### Massachusetts State Legislature Zoom Academy Staff Seminar -

The Moakley Center presented this event to provide information to new legislative staff about how the legislature works, introducing them to legislative leadership, and providing them with the tools they need to carry out their roles in public service and respond effectively to their Legislator's and Constituents' needs. While it is a time for professional development, it also provides a wider lens, focusing on the importance of public service and the high regard and responsibility that comes with Staffer positions at the Massachusetts Legislature. Ninety-seven percent (97%) of post-seminar respondents indicated that the program enhanced their professional development. Although all previous Academies have been in person, ninety percent (90%) of this year's respondents affirmed that the Zoom format was effective in successfully communicating the information presented. "Dealing with the Press" and "Acting Ethically" were reported to be the most effective segments.

# Support and advise community organizations in meeting their service missions

The Moakley Center establishes agreements with organizations across the public service spectrum, engaging with **nonprofit organizations**, **local government**, and **state agencies**. One of the benefits of the work conducted by the Moakley Center is that it provides students with an opportunity to assist with the projects. This allows graduate students the opportunity to practice the skills they are learning in the classroom and network directly with community organizations (which, in several cases, has led to employment opportunities upon graduation from the MPA program).

#### Expanding Opportunities for College Graduates with Disabilities -

Among disabled college graduates, 60% are unemployed. On average, this group takes twice as long to find employment post-graduation than their non-disabled peers. To tackle this issue, the non-profit National Organization on Disability partnered with Coca-Cola to launch Campus to Careers in 2017. The goal of this program is to assess the feasibility of developing a campus-to-employment pipeline for higher education graduates with disabilities. To achieve this goal, Campus to Careers had created partnerships with seven employers (Boston Children's Hospital, Deloitte, JPMorgan, Chase & Co., Partners HealthCare, PwC, Raytheon, and Spaulding Rehabilitation Network) and seven local colleges (Brandeis University, University of Massachusetts Amherst, University of Massachusetts Dartmouth, Northeastern University, College of the Holy Cross, Westfield State University, and Worcester State University). At these schools, Campus to Careers aims to integrate the Career Centers and Disability Services to better assist disabled students in job placements. In January 2021, the Moakley Center released its assessment of the impact of this program to assure that it is effective in increasing hiring of college graduates with disabilities.

#### 

The Moakley Center continued its long-term partnership with Boston's Higher Ground, a non-profit that aims to improve educational outcomes in the local community. The Moakley Center assisted Higher Ground by evaluating several community-based programs and initiatives, Children's Health Equity Project, Family Led Stability Pilot (FLSP), Tech Equity Project, and Community-Based Learning Pods. Most recently, the Moakley Center has begun to evaluate Higher Ground data from a 3-year study concerning the impact on school grades and attendance after housing placements for at-risk youths in the Boston Public Schools System. Following up on the 'Pilot' phase of FLSP that ended June 30, 2021 FLSP is proposing to scale up from seven to 20 schools. Nonprofit partners continuing in the second phase of the initiative are: Boston's Higher Ground will partner with Dudley Street Neighborhood Initiative (DSNI), New Lease for Homeless Families and Project Hope.

#### Women with Purpose -

The Moakley Center continued to provide support to Women with Purpose, which is an organization that empowers, educates, and advances women of color through professional development seminars, empowerment workshops, and networking events. Women with Purpose creates a safe, inclusive, and inspiring tribe of diverse women who lead authentically, strive to become a better version of themselves, and empower one another.



#### iWorks Internship Program -

For 17 years, the Department of Children and Families (DCF), in partnership with the Moakley Center for Public Management (MCPM) and Communities for People (CFP), have provided youth ages 14 to 21 with the opportunity to participate in a paid summer internship program (Summer iWorks). With the lack of placement sites and in consideration of the safety protocols that prevented in person trainings at Suffolk University, Summer iWorks was converted to a Virtual Internship Training/Work Program, and *the iWorks Publishing Company* was created. Thirtytwo (32) youth have completed an internship at the iWorks Publishing Company. By the end of this past summer, the youth had produced 4 newsletters that were distributed to DCF social workers. The fall intern cohort is creating additional newsletters and now runs a website to publish their articles, at <a href="iworksnews.wordpress.com">iworksnews.wordpress.com</a>. The Moakley Center plans to return to the onsite internship program model by Summer 2022.
