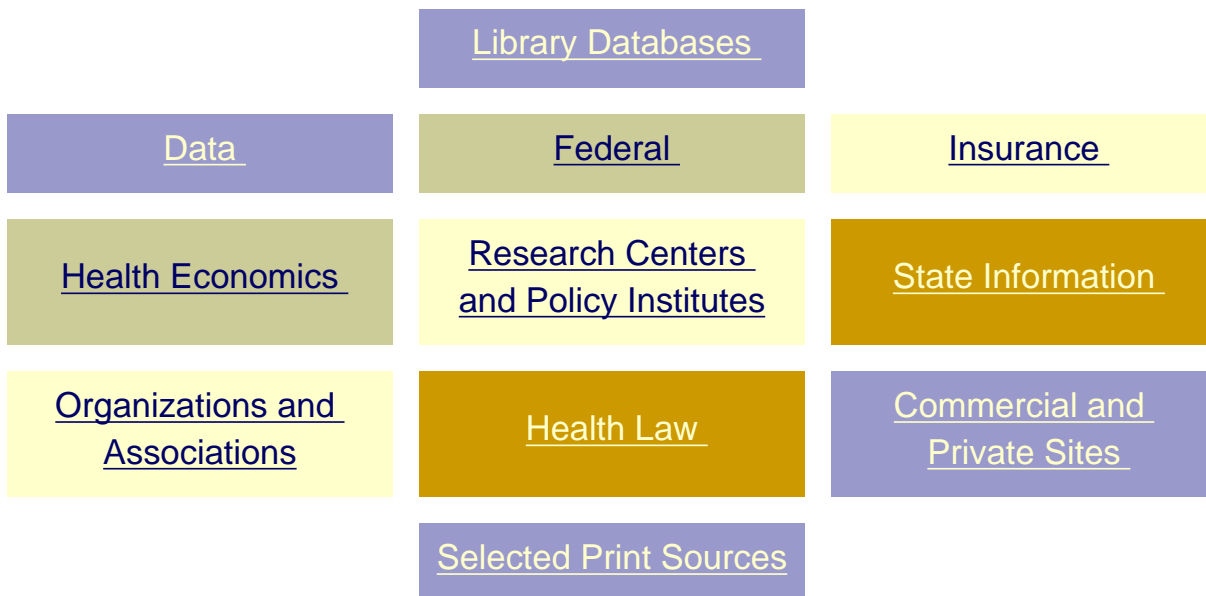


Health Administration Resource Guide

Library Databases

The Sawyer Library subscription periodical indexes and full-text resources are available to current Suffolk University students and faculty.

[Health Policy Reference Center](#)

Health Policy Reference Center is a full-text database covering all aspects of health policy and related issues, including Health Care Administration, Health Care Financing, Economics, Health Care Reform, Health Services Research, Medical Health Care Ethics and Social Medicine.

[Health Reference Center - Academic](#)

Indexes, abstracts, and provides full-text to nursing and allied health journals, medical journals, consumer health magazines, newspaper articles, and reference books.

[EconLit with Full Text](#)

The American Economic Association's database, which provides indexing and abstracting of international economic literature. It corresponds to the print Journal of Economic Literature and covers books, journal articles, working papers, dissertations, and conference proceedings. Includes full text for more than 430 journals. Coverage is from 1969 to present.

[Business Source Complete](#)

Provides indexing and abstracts for the most important scholarly business journals, including the full-text of the Harvard Business Review back to 1922. Non-journal content includes financial data, books, conference proceedings, case studies, investment research reports, industry reports, market research reports, country reports, company profiles, SWOT analyses, and more. Covers nearly every area of business, including economics, finance, management, and international business.

[MEDLINE with Fulltext](#)

Provides information on medicine, health care systems, nursing, and more. This is an enhanced version of the National Library of Medicine (NLM) database. Medline searches abstracts from 4,800 biomedical journals. Includes some linked full-text.

[SpringerLink \(includes Kluwer\)](#) (1997+)

Provides abstracts and full-text articles from over 650 Kluwer journals. Includes public health, social medicine, economic, and management journals.

[LEXIS/NEXIS Academic](#)

Contains a massive database of worldwide general, legal, health, and business news. Provides full-text searching of newspapers, trade journals, wire services, and transcripts of broadcasts. Business, legal, and biographical sections are included. Newspaper coverage generally starts in the late eighties or early nineties.

[ScienceDirect](#)

ScienceDirect includes over 2,000 academic journals with full text, most back to 1995. It provides an extensive source of high-quality, peer-reviewed journal literature in all areas of the sciences.

[JSTOR](#)

Contains back runs of over 700 scholarly publications in various academic fields. Search by category or within a particular journal. Includes political, economic, management, and science journals.

[Academic OneFile](#)

Academic OneFile is Gale's major source for peer-reviewed, full-text articles. It provides extensive coverage in all academic subjects, including the social sciences, biological sciences, and economics.

[Academic Search Complete](#)

A full-text database with more than 5,500 full-text periodicals, including more than 4,600 peer-reviewed journals. Covers all academic subjects, including the social sciences, economics, and medical sciences.

[Science Magazine](#)

The full text of *Science* issues since January 1997. Science is one of the leading journals of original scientific research, global news, and commentary.

[Sage Journals Online](#)

Sage Journals Online consists of PDF online content to ALL the academic journals published by the scholarly publisher, Sage, including deep back files. This is approximately 450 peer-reviewed journals covering various fields, including health management, public health, health economics, and patient care.

[Wiley Interscience. \(Includes Blackwell\)](#)

Provides searching and indexing of scholarly journals in all academic fields, including medical science, economics, and management. Journal articles are available in PDF.

More than one million citations and abstracts to scholarly journal articles, book chapters, books, and dissertations.

Searchable full-text articles from 42 journals published by the APA and allied organizations.

[Health and Wellness Resources Center](#)

Provides access to full text articles from reference and periodical literature. Includes news and health-related pamphlets.

This database includes searchable Diagnostic and Statistical Manual of Mental Disorders (DSM-IV-TR), textbooks, and journals.

Included are more than 60 indicators that cover the period from 1990-2015. The purpose is to measure each country's level of progress toward development and elimination of poverty. The 2008 report is available in PDF or and online version is available with free registration.

Healthcare Cost and Utilization Project (HCUP) is health care databases and software tools developed through a Federal-State-Industry partnership and sponsored by the Agency for Healthcare Research and Quality. Allows the creating of user-defined tables and graphs on national and regional statistics and trends for community hospitals in the U.S.

Topics and programs covered include bioterrorism, business and administration, Congressional testimony, disability and aging, health policy issues, privacy, welfare reform, and more. The [NLM Gateway](#) allows users to search multiple retrieval systems at NLM, including MEDLINE/PubMed, LOCATORplus (catalog records), ClinicalTrials.gov, MEDLINEplus (consumer health topics), meeting abstracts, and more. AHRQ, a part of the U.S. Department of Health and Human Services, is charged with supporting research to improve the quality of health care, reduce its cost, improve patient safety, decrease medical errors, and provide access to essential services. The website provides consumer health information, clinical practice guidelines, and selected full-text reports and studies. Includes data and survey information. HCUPnet, for example, is a tool for identifying and analyzing statistics on hospitals at the national, regional, and state levels. It allows the user to create their own parameters for data access. The AHRQ also maintains a [Grants On-Line](#) database of AHRQ funded grants, searchable by topic and state.
