Periodical Indexes and Full-text Databases

[Business Source Premier](#)

Provides indexing and abstracts for over 3,800 business journals and cumulative full-text for over 3,000 journals. Covers nearly every area of business including public administration areas such as government policy, personnel management, budgeting, economics, finance, and management. The full-text of *Public Administration Quarterly* is included in this database from 3/83 to the present.

[EconLit](#)

This is the American Economic Association's database, which provides indexing and abstracting of international economic literature including fields such as government regulations, public finance, and urban economics. Coverage is from 1969 to present. Some links to full-text articles.

[General BusinessFile ASAP](#)

Provides indexing, abstracting and a substantial amount of full-text for business and management topics. Coverage is from 1980 to the present.

[Academic Search Premier](#)

Our best general research database, this online resource provides indexing and abstracting for 4,500 scholarly publications with full-text access for over 3,600 of the titles. Indexing and abstracting coverage generally from the mid-1980's and full-text coverage for many titles dating back to 1990. You may limit search results to full-text and peer-reviewed articles. Coverage of many academic areas including social sciences, humanities, education, and business.

[Academic OneFile](#)

Provides indexing and abstracting of more than 8,000 journals and magazines in the social sciences, humanities, and science and technology. You may limit search results to full-text or peer-reviewed articles or articles with images. Full-text is provided for about two-thirds of the publications.

[CQ Researcher](#)

This full-text database contains reports on topics of current interest, many of which deal with social issues and current events. Each report includes sections on background, outlook, chronology, bibliography, and pro/con views of the issue. [CQ Weekly](#) reports on past and present legislative issues discussed by the U.S. Congress plus the status of bills in play, committee and floor activity, debates, and roll-call votes.

[SocINDEX with Full Text](#)

This database contains full-text for about 450 journals as well as full-text for more than 700 books and 6,000 conference papers. Subject areas covered include: "abortion, criminology & criminal justice, demography, ethnic & racial studies, gender studies, marriage & family, political sociology, religion, rural & urban sociology, social development, social psychology, social structure, social work, socio-cultural anthropology, sociological history, sociological research, sociological theory, substance abuse & other addictions, violence and many others."

[Sociological Abstracts](#)

This bibliographic database includes topics such as demography, social psychology, economic and community development. It may be searched concurrently with Social Services Abstracts, an index to literature in the areas of social work, human services, social welfare, and social policy.

[Criminal Justice Abstracts](#)

Indexes and abstracts international journals, books, reports, dissertations and unpublished papers on criminology and related disciplines including crime trends, courts and the legal process, and economic and political sciences. This database may be searched concurrently with [Criminology: a SAGE Full-Text Collection](#) which covers topics such as crime trends, corrections, penology, policing, and crime prevention.

[LexisNexis Academic](#)

Comprehensive database contains full-text news articles in major U.S. and foreign newspapers, and also provides full-text access to legal periodicals, case law, and U.S. codes and regulations.

[LexisNexis Statistical](#)

LexisNexis Statistical provides access to statistics produced by state and federal government, major international organizations, professional and trade associations, commercial publishers, research organizations, corporations, and universities.

[JSTOR](#)

Contains the full-text back runs of over 300 scholarly publications in various academic fields, including business, economics, finance, and political science. Search by category or within a particular journal. The "Public Policy & Administration" category includes *Public Administration Review* (1940-1999), *Administrative Science Quarterly* (1956-2001), *Educational Evaluation and Policy Analysis* (1979-1999), *Journal of Public Administration Research and Theory: J-PART* (1991-1999), and *Philosophy and Public Affairs* (1971-1999).

[Census of Governments: Federal, State and Local Governments](#)

The *Census of Governments*, part of the Census Bureau's Economic Census, has been conducted every 5 years since 1957. 87,000 state and local governments are surveyed, which includes counties, cities, towns, special districts, and school districts. The collected data includes the characteristics of local governments, financial data (revenue, expenditure, debt, assets) and employment data (employees, payroll, and benefits). Selected [publications](#) from the 1992, 1997, and 2002 *Census of Governments* are also available in full-text PDF format (<http://www.census.gov/prod/www/abs/govern.html>). Print copies of the [1977](#), [1982](#), and [1987](#) *Census of Governments* are available in the Sawyer Library's Reference collection.

[State of the Cities Data Systems \(SOCDS\)](#)

SOCDS is comprised of selected statistics collected by the Census Bureau and the Bureau of Labor Statistics. Selections include employment, crime, building permits, and urban public finance data. *SOCDS* is provided by HUD User, an "information source for housing and community development researchers and policymakers," established in 1978 by the U.S. Department of Housing and Urban Development's (HUD's) Office of Policy Development and Research (PD&R).

The *Abstract* is a summary of selected statistics on the "social, political, and economic organization of the United States" with an emphasis on national data. It is also available [online](#) 1878 to date in PDF format.

The Sawyer Library has this publication (issued irregularly) from 1997 onwards. The *Handbook* presents industry data and historical data on employment, hours, and earnings for each of the 50 states (including statistics for selected areas within states) and the District of Columbia.

Published by the Massachusetts Municipal Association, this directory provides fiscal and demographic data and the names, titles and contact information for all the cities and towns in Massachusetts.

[Book of the States](#)

REF. JK2403 .B62

Written primarily for policy-makers and managers in state government, this annual publication produced by The Council of State Governments provides information and data (e.g. summary of federal government expenditure by state) on many areas in state government. It also reports on trends in areas such as government accounting, auditing and treasury.

[CSG State Directory](#)

REF. JK2403 .B623 (latest issues only)

Issued annually by The Council of State Governments, the 2005 *Directory* consists of 3 issues. *Directory I---Elective Officials* contains the names and contact information for state officials such as the governor, secretary of state, attorney general and treasurer. *Directory II---Legislative Leadership, Committes and Staff* identifies and provides contact information for Senate and House officers, heads of selected Standing Committees, and Legislative Agency staff. *Directory III---Administrative Officials* "provides basic information about elected and appointed officials with primary responsibility in more than 110 state government functions."

[State Tax Handbook](#)

Provides an overview of taxation schemes for each state plus multistate charts on income, sales, and use taxes. Includes state administrative provisions.

[Cultures of the States: a Handbook on the Effectiveness of State Governments](#)

REF. JK2408 .F79 2003

The authors have collected and analyzed state statistics on mortality, health, education, crime and punishment, and the economy and created state comparisons as well as a "problems profile" for

each state. The annual publication [State Rankings](#) (REF. HA203 .U17) provides over 500 tables of state comparisons in areas such as agriculture, education, energy and the environment etc.

The International City/County Management Association publishes this annual which includes articles and data that address local government concerns. Broad categories include: management trends and issues, intergovernmental issues, staffing and compensation, and directories.

Provides "the most up-to-date statistical information available for every state, county, metropolitan area, congressional district, and for all cities in the United States with a 2000 population of 25,000 or more."
