Periodical Indexes and Full-text Databases

The Sawyer Library subscription periodical indexes and full-text resources are available to current Suffolk University faculty and students.

[Academic Search Complete](#) (EBSCO)

Provides full-text access to more than 5,500 periodicals, including more than 4,600 peer-reviewed journals including philosophy journals.

[Biography Resource Center](#)

Combines over 400,000 biographies from over 90 Gale Group reference sources. Includes the complete *Marquis Who's Who* and full-text articles from 250 magazines.

[Academic OneFile](#) (InfoTrac)

Academic OneFile is Gale's major source for peer-reviewed, full-text articles. It provides extensive coverage in all academic subjects and offers millions of articles in both PDF and HTML full-text.

[Cambridge Collections Online](#)

The Cambridge Collections Online is the online version of the Cambridge Companions, published by the Cambridge University Press. There is one main collection, The Complete Cambridge Companions, and two sub-collections comprising the Cambridge Companions in Literature and Classics and the Cambridge Companions in Philosophy, Religion and Culture. Titles include *The Cambridge Companion to Early Greek Philosophy*, *The Cambridge Companion to Bertrand Russell*, *The Cambridge Companion to Arabic Philosophy*, and others.

This journal collection includes more than 1,200 peer-reviewed journals. Most titles include back issues to 1996. Provides abstracts and full-text articles from Kluwer journals. Journals cover religion and philosophy subjects.

Provides full-text scholarly journals of the Johns Hopkins University Press and its publishing partners. More than 15 journals are in the field of Philosophy. Results are full-text.

Provides abstracts and full-text articles from over 650 Blackwell journals, covering subject areas, such as philosophy and theology. More than 25 journals are part of the philosophy collection.

Provides indexing and abstracting of humanities journals plus the full text of 670 journals.

Provides a searchable Britannica plus related websites.
