The Oxford African American Studies Center provides full-text access to several publications from Oxford University Press relating to African American studies, including:

This collection of online reference works from Thomson Gale publishers includes several titles useful to African-American studies (*African American Almanac*, 9th ed., 2003; *African-American Years: Chronologies of American History and Experience*, 2003; *Encyclopedia of African-American Culture and History*, 6v, 2006; *Encyclopedia of African American Society*, 2v, 2005; *Encyclopedia of Black Studies*, Vol. 1, 2005, and *Who's Who Among African Americans*, 18th ed., 2005), as well as more general sources like the 10 volume *Dictionary of American History*.

The full text of this three volume set (published by ABC-CLIO eBooks) is available online. The set is comprised of historical and primary documents depicting the African American experience, from the 1600s to 2008.

[History Resource Center: U.S.](#)

History Resource Center: U.S. provides a complete overview of U.S. history, with a broad range of content types: digital archives of primary source material (documents, monographs, pamphlets, first-person accounts), encyclopedias, scholarly journals, and audio and video clips of historic speeches and events. A title unique to this collection is the *American Journey Online: The African American Experience*, which gathers primary source materials spanning from the colonial period through the civil rights era.

Sage eReference is an online collection of over 40 reference titles from Sage Publications. Users may search across all titles, or browse by subject. Two titles are specific to African American Studies: the *Encyclopedia of African American Society*, and the *Encyclopedia of Black Studies*.

[Cambridge Histories Online](#)

Cambridge Histories Online provides electronic access to over 250 scholarly volumes published by Cambridge University press since 1960. A sample search for "African American" generates 305 results, the bulk being from The Cambridge History of American Literature, The Cambridge History of Law in America, and The Cambridge History of Music.

[CQ Press Political Reference Suite](#)

CQ Press's Political Reference suite is a collection of reference book titles on government and politics. Sources include: CQ Almanac (legislative analysis and policy tracking, 1945-2006); Congress and the Nation (legislative history and policy analysis, 1945-2004); Historic Documents Series (key primary source documents, 1972-2005); Politics in America (congressional profiles, 2000-2006); Supreme Court Yearbook (case summaries and analysis, 1989-2005); and Vital Statistics on American Politics (elections, public opinion, voting). Examples of materials that may be retrieved from this set include a legislative chronology of Civil Rights from 1945-1964 (in Congress and the Nation), and the full-text of speeches such as Governor Wilder's Inaugural Address (Virginia, January 13, 1990) - the first black to be elected governor of any state (in the Historic Documents Series).

[Historical Statistics of the United States](#)

This is the updated, online edition of the standard reference source for historical U.S. statistics. It contains more than 37,000 annual time series of historical information, arranged in broad data areas- population, work and welfare, economics governance. For example, an article on the history of slavery in America links to multiple tables with statistics on the demography and economics of slavery.

JSTOR allows searches to be limited to a set of eight journals in African American Studies: *African American Review*, 1992-2001 [previously *Black American Literature Forum*, 1976-1991;

and *Negro American Literature Forum*, 1967-1976]; *Callaloo*, 1976-1994; *Journal of Black Studies*, 1970-2001; *Journal of Blacks in Higher Education*, 1993-2002; *Journal of Negro Education*, 1932-1999; *Journal of Negro History*, 1916-2001; *Phylon* (1960-) 1960-1992 [*Phylon Quarterly* 1957-1959; *Phylon* (1940-1956) 1940-1956]; and *Transition*, 1961-1999.

A team of researchers at Harvard University, under the supervision of Henry Louis Gates Jr., have discovered over nine hundred such publications." Facsimilies of the black periodicals and newspapers have been produced on microfiche. The Sawyer Library owns microfiche 1-993. This collection is accompanied by an author/title index to unit 1 (microfiches 1-198), an index on CD-ROM, and a user's guide to units 1-3 on a separate set of 39 microfiches.

Lexis contains the full-text of hundreds of domestic and international newspapers, including *The New York Times* (1980 -), the *Boston Globe* (1988 -), the *Boston Herald* (1994 -), and *The Washington Post* (1977 -). Users can retrieve full-text articles, including obituary articles; however advertisements, illustrations, and classifieds are not available. Use the News section or the People section (Biographical Information) to search for articles and directory information.

This is the online version of the extensive reference set, the Dictionary of Literary Biography, the main series, as well as Dictionary of Literary Biography Documentary Series and Dictionary of Literary Biography Yearbook Series. The purpose of the DLB series is not only to provide career biographies of important writers, but also to provide an overview of specific areas of literature and to discuss the writers within "the larger perspective of literary history and to offer appraisals of their accomplishments by qualified scholars." The volumes are organized by topic, period, or genre as appropriate, and hence each volume serves as a stand-alone reference source. Users may search or browse through the complete online set. The scope includes not only creative writers, but also biographers, autobiographers, historians, journalists, literary critics, book illustrators, scholars, and bibliographers.

A biographical dictionary of artists of African descent. Each entry includes biographical and career information as well as a brief illustrated discussion of the artists work. The primary focus is on artists of the twentieth century, however some nineteenth century artists are included. African Americans make up the majority of the selected artists, with artists from Africa, the Caribbean and other areas of the African diaspora making up the remainder.

This volume includes biographical information, the full-text of speeches, and background information on the events and people contributing to the circumstances of each speech. The book is arranged alphabetically by speaker, with an ethnicity index, a speech category index, and a keyword index.

The Trans-Atlantic Slave Trade Database is a unique achievement of collaboration amongst academics, sponsored in part by the National Endowment for the Humanities and Emory University Libraries. This publicly available, online database gathers information on 34,941 trans-Atlantic slaving voyages between the years 1514 and 1866. Records and documents held in archives and libraries on both sides of the Atlantic provide information on the vessels, slave traders and owners, the enslaved peoples, trading routes, ports, and individual names, as recorded at the time.

These narratives were collected in the 1930s as part of the Federal Writers' Project of the Works Progress Administration (WPA) and assembled and microfilmed in 1941 as the seventeen-volume Slave Narratives: A Folk History of Slavery in the United States from Interviews with Former Slaves. This online collection is a joint presentation of the Manuscript and Prints and Photographs Divisions of the Library of Congress and includes more than 200 photographs from the Prints and Photographs Division that are now made available to the public for the first time. Born in Slavery was made possible by a major gift from the Citigroup Foundation."
