Library Databases

Education Research Complete is a bibliographic and full-text database of scholarly educational research and information. It offers indexing and abstracts for more than 1,870 journals, full-text for more than 1,060 journals, full-text for 133 books and monographs, and full-text for education-related conference papers.

[ERIC](#)

ERIC, the Educational Resource Information Center, is a national information system supported

by the United States Department of Education. This database contains abstracts and journal articles on educational research and practice. Limited full-text is available.

Offers more than 450 full-text academic journals and hundreds of full-text reports, focusing on the field of education. Much of the full-text titles included are also found in the ERIC database.

Searchable full-text articles from 42 journals published by the APA and allied organizations. Includes journals covering cognition, memory, and assessment.

[PsycInfo](#) (1887+)

More than one million citations and abstracts to journal articles, book chapters, books, and dissertations, including citations to educational research, studies, journals, and dissertations.

[Academic Search Complete](#) (EBSCO)

Provides access to a wide variety of journals and periodicals, covering all academic disciplines. Many articles are available in full-text.

[Academic OneFile](#) (InfoTrac)

Academic OneFile is Gale's major source for peer-reviewed, full-text articles. It provides extensive coverage in all academic subjects and offers millions of articles in both PDF and HTML full-text.

SAGE Journals Online provides full-text of more than 520 journals in business, humanities, social sciences, and science, and medicine. A small example of the topics in education covered include policy, assessment, curriculum development, early intervention, higher education, educational research, and teacher education.

[Mental Measurements Yearbook](#)

Created by the Buros Institute at the University of Nebraska, this database provides evaluations for over 2,000 contemporary testing instruments, covering psychology, education, business, and leadership.

Provided by the Buros Institute of Mental Measurements at the University of Nebraska, this database is a bibliography of all known commercially available tests that are currently in print in the English language. It offers information including test purpose, test publisher, in-print status, price, test acronym, intended test population, publication date, and test author.

Contains a massive database of worldwide general, legal, health, and business news. Provides full-text searching of newspapers, trade journals, wire services, and transcripts of broadcasts. Business, legal, medical, and reference sections are included. Newspaper coverage generally starts in the late eighties or early nineties.
