Library Databases

The Sawyer Library subscription periodical indexes and full-text resources are available to current Suffolk University students, faculty, and staff.

[SocINDEX with Full Text](#)

Indexes over 2,600 journals, and contains 253 full-text core coverage journals and the texts of 72 priority journals.

[Sage Journals Online](#)

Provides online access to the full-text Sage research journals (including deep backfiles) in

specific fields. Includes 37 Sociology and 23 Criminology journals.

[Academic Search Complete](#)

A full-text database with more than 5,500 full-text periodicals, including more than 4,600 peer-reviewed journals. Covers all academic subjects.

[Academic OneFile](#) (InfoTrac) (1980+)

Provides indexing, abstracting, and full-text coverage of over 8,000 journals covering every academic field.

[JSTOR](#)

A full-text collection of back issues of core scholarly journals, covering specific subject areas. Search by category or within a particular journal.

[LEXIS/NEXIS Academic](#)

Provides full-text searching of newspapers, trade journals, wire services, and transcripts of broadcasts. Newspaper coverage generally starts in the late eighties or early nineties. Legal, medical, and reference sections are included. Legal databases include state and federal codes, appellate level state and federal case law, law reviews, legal news, federal regulations, and more.
