Series I: Rosalie L. Warren Papers, 1979-1997

Description: The collection contains the personal papers of Rosalie L. Warren, a beloved Suffolk University student and benefactor who started her undergraduate studies at the age of seventy-five as part of the university's senior citizen program. The photographs, correspondence, newspaper clippings, certificates and other items document her student days at Suffolk University and her philanthropic activities. The collection also includes poetry written by Warren and others.

Warren was born Rosalie Levy on August 29, 1900 in Leeds, England. She moved to the West End of Boston with her parents around 1909. Being the oldest of ten children, Rosalie was forced to withdraw from Boston's High School for Girls at age sixteen in order to help contribute to the family's finances. From then on, Rosalie's education was sporadic. She attended lectures at the University of Lowell and took classes at Harvard Extension. In her early twenties, she completed classes at Boston University for stenography, typing and office management in order to attain skills to use in the work field. However, Rosalie always longed for higher education.

At age seventy-five, Rosalie Warren began attending Suffolk University in 1976 through the university's senior citizen program that allowed seniors to attend the university free of charge. In 1980, Warren graduated magna cum laude and earned her B.A. in Philosophy. She also received the award for highest achievement in philosophy at Recognition Day. Warren forfeited the cash prize that came with the award and donated it back to the university in recognition for what the university had given her. Thomas A. Fulham, president of Suffolk University, the award as the Rosalie L. Warren Prize in Philosophy. Rosalie continued to contribute to the award after graduation and her family established two other prizes for honor students. Warren's sister started the George J.



Levy Memorial Prize in History in honor of their brother and Warren's nephew Dr. Paul H. Levy established the Rosalie L. Warren Prize in English.

Warren returned to Suffolk and earned her Master's degree in Education (M.Ed.) in 1983 making her the university's oldest woman to receive a degree. Warren remained active on campus with student organizations, fundraisers, and university events. She was very much revered by students, faculty and staff. In 1987, she was honored as the Outstanding Alumni of 1987, an award given by the General Alumni Association to those providing outstanding service to the university. She continued to be one of the University's biggest advocates and continued to audit classes in psychology and sociology up until she was ninety-six years old. Warren passed away on January 26th, 2003 at the age of one hundred and two.

Series II: George C. Kendall Scrapbook, 1903-1944

Description: This scrapbook documents aspects of George Christopher Kendall's early life and career from 1903-1944. Kendall was born on August 22, 1885 in British Guiana, South America. He was employed as a letter carrier for the government post office from 1901 until 1910 and later managed a theatrical group called the Merry Makers.

Kendall emigrated to the U.S. in 1911 but after four years left for Canada to work for the Canadian Pacific Railway Co. Between the years of 1915 and 1921, Kendall travelled between Canada and the U.S. to attend Armstrong Tech High School in Washington D.C. and New York Electric School in New York City. During his residency, he studied at the Wheeler Prep School. He then entered Suffolk Law School in 1924 and graduated in 1928 but never practiced law. In 1933, Kendall was married to Rose Crutcher Knox. Kendall spent most of his adult life in Boston and Woburn, MA.

The scrapbook includes his Canadian passport, employment papers, handwritten journals, academic certificates, license renewals, wedding invitations, personal photographs, cancelled will, and sheet music written by Kendall.

Series III: Commonwealth of Massachusetts vs. Nicola Sacco hearing transcript, 4/15/1920

Description: This transcript documents a pre-trial hearing related to the Sacco and Vanzetti Trial of 1921. The hearing took place at District Court in Braintree, MA on April 15, 1920, where Nicola Sacco stood accused of murdering Alessandro Berardelli. The defendants in the case were Italian-born anarchists who were convicted of murdering two men during an armed robbery of a shoe factory in South Braintree, Massachusetts in 1920.

Series IV: Gaylord A. Freeman Jr. Far East and Oceania Letters Collection, 1967

Description: Generally referred to as the “Far East Letters,” this collection contains a series of letters written by Gaylord A. Freeman Jr. (ca. 1910-1991), an executive at First National Bank of Chicago, to then CEO and president of First National Bank Homer J. Livingston. Freeman, along with his wife, travelled to Hong Kong, Singapore, Korea, Malaysia, New Zealand, Australia, and Moorea from April 23 through May 4, 1967. Often only spending a few days in each location, Freeman wrote back to Livingston reporting on the economic and cultural climate. It is believed they were used to inform the bank’s business development overseas. Some of the letters also include maps illustrating data such as population, geographical information, and economy. Freeman forwarded multiple copies of these letters to colleagues and friends; this collection



contains copies sent to Freeman’s associate John S. Moore. View [digitized versions](#) of the letters.

Series V: Patrick J. Daley Notebooks & Exams Collection, 1919-1939

Description: This collection contains the notebooks and personal documents of Patrick Joseph Daley. Daley, who occasionally went by Joe, was born in the United States, and at one point moved to Ireland, then back to the United States where he became a resident in Wakefield, Massachusetts. Between the years 1919-1925 Daley attended Suffolk Law School, and after went on to write articles with the Wakefield Daily Newspaper. Daley was married to Elizabeth Nora Curran and together they had one son, Donald Daley, whose children and grandchildren still reside in Massachusetts.

His notebooks include his own handwritten class and personal notes, practice exam questions, statutes, past bar exam questions, Irish language learning books and dictionaries, and his letters of recommendation for employment.
