Meet Our Cataloger



Tucked away on the 7th floor of the Moakley Law Library, near the utility elevator, are the library's office suites. In there, you'll find Julie Ann Hogan, the library's copy cataloger, who has worked here in that capacity for twenty-seven years.

Julie said, "I put down my roots and that's it." And she means it. Before tech services, she worked at the circulation desk as a student; she

graduated from Suffolk in 1993 with a B.S. in criminology and sociology. Her son TJ is now studying criminology at Suffolk, and her son Anthony will be starting at Suffolk with the same major this fall – like mother, like sons!


Julie liked cataloging right from the start. She loves getting information to patrons and is dedicated to keeping records clear and uniform. She was here in 1994 when the library made the transition from paper to electronic records. The switch was hectic and required barcoding thousands of books from scratch. Because she has been with the online catalog since its inception, she is *obsessive* about making the records perfect. (we work with her – we know!) Every record has been fine-tuned by Julie, including all the hyperlinks for the electronic records. Without her efforts, it would be impossible to locate the library's paper books and e-resources.

Working in a library comes with challenges and staff members must be adaptable. Recently, due to COVID-19, the library had to close and halt its deliveries back in March. Tons of boxes of books had to be opened and cataloged when technical services staff returned in August. To get course reserves ready, Julie came to the office in person, sometimes working twelve-hour days to make sure that books were available for students when school started.

In addition to cataloging, Julie is a member of the library's Fun Committee, decorating the office for the holidays, hosting potlucks, and running silly trivia contests for everyone who works at the library. She loves working with her colleagues at Suffolk (thanks, Julie!) and cannot imagine being anywhere else.




