## **Study Rooms**

You'll also find useful expert demonstrations and Self Guided Professional Development Plans in your practice area under MCLE's Practice Portals. ## Westlaw and Lexis Summer Use Policy for Students

#### Westlaw

You can use Thomson Reuters products, including Westlaw®, Practical Law, and the Practice Ready solutions over the summer for non-commercial research. You can turn to these resources to gain understanding and build confidence in your research skills, but you cannot use them in situations where the work you are doing is related to a paying client.

Examples of permissible uses for your academic password include the following:

- Summer coursework
- Research assistant assignments
- Law Review or Journal research
- Moot Court research
- Non-Profit work
- Clinical work
- Externship sponsored by the school

You do not have to do anything to gain access to these tools over the summer. Once again, Lexis is providing full access to Lexis+® through student law school IDs throughout the months of June, July and August. Continued access includes tools, search history and the same exclusive content and practical guidance. Whether clerking, interning or working at a firm, students can use their law school access. (Note that some employers may prefer that summer associate use a firm provided ID for client work.)

#### **Prepare to Practice**

There's still time for students to complete the popular LexisNexis Prepare to Practice program that helps students succeed in summer and permanent employment. On-demand activities focus on the practical skills that summer associates and new associates identified as critical to their success. A new module added to the program covers legal analytics.

## Westlaw and Lexis Access for Recent Graduates

#### Westlaw

All 2023 SULS graduates can use Thomson Reuters products, including Westlaw and Practical Law, for a full eighteen (18) months after graduation. Your "Grad Elite" access gives you 60 hours of usage per month. That means you can access Westlaw remotely, from any device, anywhere, for personal and work projects. If you haven't already, be sure to go to <a href="telewestlaw homepage">the Westlaw homepage</a> log in, then use the drop-down menu by your name to go to Grad Elite Status. #### Lexis+

Through student law school IDs all 2023 SULS graduates will have access to Lexis+ for six months after graduation. This is done automatically and students do not need to sign up. If you are going to work for a 501(c)(3) non-profit organization, you can apply to extend this access for one year following graduation through the Lexis Aspire program. 
Her honor: stories of challenge and triumph from women judges / Lauren Stiller Rikleen, editor; foreword by Dahlia Lithwick
