Antitrust. Develop and teach doctrinal antitrust three-credit semester-long course on substantive antitrust law. The course focuses on US-based antitrust regimes, including those governed by the Sherman Act, the Clayton Act, and other statutes and regulatory regimes on the topics of monopolization, horizontal and vertical restraints of trade, mergers and acquisitions, and intellectual property exemptions. Develop and facilitate assignments, quizzes, exams, handouts, online lectures, case study materials, and practitioner interviews.

Legal Practice Skills “LPS”. Teach five-credit year-long course on formulating legal analysis through legal research and legal writing assignments, including both litigation-focused assignments, such as objective and persuasive office and trial memoranda, and transactional-focused assignments, such as contracts and agreements. Develop assignments, handouts, activities, and lecture slides. Provide students with feedback on various assignments. Coordinate transactional drafting module for entire LPS program. Supervise one Teaching Assistant.

Transactional Skills. Develop and teach three credit semester-long course on transactional skills used throughout the life cycle of a company, including contract drafting, transactional research, ethics, negotiation, and other skills. Teach students about the power transactional lawyers possess to influence change in society, including through examples and exercises related to current events on topics such as Inclusion Riders. Develop assignments, handouts, activities and lecture slides. Provide students with individual and group feedback.
