Copyright Law (3cr/6ECTS) - The course focuses on learning core doctrines in Copyright law, making students familiar with the legislative framework and the challenges that face copyright holders and users in creating, exploiting and protecting copyright works. Students focused on writing not just legal briefs but also how to write policy briefs and papers. (Role: Course Developer and Deliverer)

Intellectual Property Transactions (3cr/6ECTS) - This course teaches students about the contractual issues surrounding licensing of intellectual property: patents and trade secrets; trademarks; copyrights and designs. The course examines selected topics focusing on the differing considerations regarding transactions in licensing different types of intellectual property as well as addressing the ongoing issues regarding software sales and licensing, e.g., shrink-wrap, OEM, and other license agreements. The course is built around a semester long legal problem with a client such as an independent filmmaker licensing their documentary to Netflix. (Role: Course Developer and Deliverer)

Legal Innovations (3cr/6ECTS) - This course is a hands-on student incubator for the development of startups. It is intended to give students the experience of what it is like to be on both sides: an innovator and an advisor to innovators. Early classes focus on the ideation of a legal startup and fundamentals of developing a business plan. Once students establish their startup ideas a series of guest speakers provide feedback to help shape the ideas into viable business plans and pitches. Students come away from this course with the practical knowledge of what it takes to establish a startup business from idea to pitch, addressing issues of patenting, trademark and copyright at each stage. (Role: Course Developer and Deliverer)
