Training aims include preparing Interns for entry-level practice in higher education settings, increasing multicultural competency with a focus on social justice, and assistance with the development of an authentic professional and personal identity. CHW provides a dynamic and supportive training and working environment. Training staff maintain an integrated approach to clinical work, with a focus on empirically based short-term and relational-cultural models. CHW seeks to maintain an inclusive environment for service delivery, staff engagement, and training; staff are committed to intentionally addressing issues of diversity and identity, interpersonal sociocultural differences, and social justice.
